WHAT IS IRS FORM 2290?

IRS form 2290 is a federal tax on heavy-duty vehicles weighing 55,000 pounds or more and used for 5,000 miles or more. The IRS 2290 form/IRS HVUT is an annual tax that is used to build and maintain government highways in the United States.

WHO MUST FILE IRS FORM 2290?

- If you've used your vehicle for the first time in the current month, then IRS HVUT must be filed within the last day of the following month. For instance, you've used your vehicle for the first time in April during the tax year 2018-19, then 31st May 2019 is the last day to file your IRS form 2290 for 2018-19.
- 1st July of the current year to 31st August of the succeeding year is considered as the tax period. 31st August 2019 is the last day to submit HVUT for the financial year 2018-19. If the HVUT is not paid by this date, then the penalty is imposed by the IRS.

HOW TO FILE FORM 2290?

When you file with eForm2290, an IRS-authorized e-file service provider, you can do it easily in just 4 steps:

- Choose your 'business'
- Select the 'tax period' and 'first used month' of your vehicle
- Enter your vehicle information
- Click on the IRS payment / EFTPS

WHAT ARE THE REQUIREMENTS TO FILE FORM 2290

Filing IRS 2290 form with eForm2290 is simple and easier. You need these things to file the IRS HVUT online with eForm2290.

- EIN (employer identification number)
- VIN (vehicle information number)
- The gross weight of the vehicle
- Name and address of your trucking business

WHEN TO FILE IRS FORM 2290

If you have registered a heavy highway vehicle with a gross weight of 55,000 pounds or more in your name with the IRS, then you must file IRS form 2290 and pay the HVUT. If you've used your vehicle for the first time in the current month, then IRS HVUT must be filed within the last day of the following month. When you file with eForm2290, you will receive your Schedule 1 copy in a few minutes after IRS accepts your tax filings. Same rules apply irrespective of whether you're paying the tax or reporting suspension of the tax.

IRS FORM 2290 PAYMENT OPTIONS

- You can file IRS heavy use tax form 2290 and pay heavy use tax form 2290 returns by any of the following methods:

- Paper filing
- e-Filing

IRS suggests the truckers file heavy use tax form 2290 online since it is easier, secure and faster than paper filing. Not only this, paper filing of form 2290 heavy highway vehicle use tax return requires you to manually mail your returns to the IRS office, where you have to make an appointment with the IRS office and wait in the queue just to pay your 2290 heavy duty taxes. Additionally, when you file your heavy highway form 2290 online, you will get your stamped schedule of highway vehicles copy within 15 minutes of IRS acceptance, but for paper filing of form 2290 heavy highway vehicle use tax return, this will take about 5-45 days to receive your copy.

IRS PENALTIES

If you fail to pay taxes on time or fail to file your returns, then the IRS imposes penalties. There are additional penalties along with an interest charge on late payments. You're also subjected for penalties for filing false returns.

But if there is a valid reason for late payment of your tax or failing to file your returns, the IRS may consider it and you can be exempted from penalties. But if you file your returns after the due date (including extensions), you need to attach a valid explanation along with your returns.
